# Managing International Student/Scholar/Staff

- All of your F/M/J students/scholars/staff will have an easily searchable electronic file in TDS
- These files can be used to store all of the information that needs to be sent and updated in SEVIS

## **Of particular interest to Admins (DSOs/AROs)**

- Update user files en masse
- All user data is searchable and reportable. No need to wait - get the reports you need when you need them.
- Easily target specific groups of users and communicate with them via email or SMS which are tracked and reported in their file
- Report changes in Batch to SEVIS-required data that has been added or edited in user's file TDS (SEVIS Module Clients only)

## **Of particular interest to Students/Scholars/Staff (Users)**

- Log in to TDS and monitor their immigration status
- Report updates relevant to their academic/immigration status and request SEVIS benefits conveniently online
- Access important and personalized information related to their academic/immigration status securing online via the TDS portal

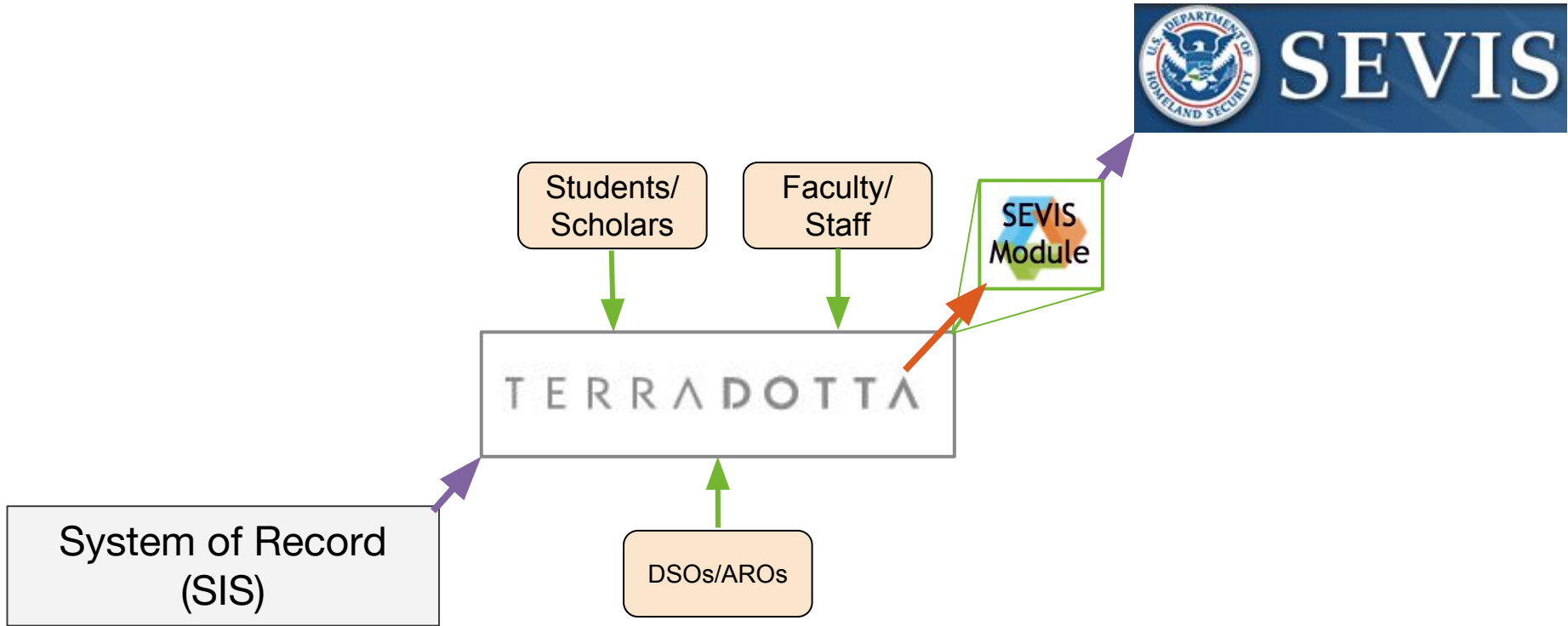


# Managing International Admissions

- International applicants can apply for admission to your institution
- Applicants can upload scanned images of immigration, unofficial transcripts and financial support documentation directly to their application
- All action taken on applications (both by institution staff and applicants) are date and time stamped
- Applications can be easily reviewed by both Admissions Counselors and other relevant faculty/staff on campus

# Scripted SEVIS-Mapped Fields in TDS for ISSS

- Every field in SEVIS has a corresponding field in TDS.
- SEVIS Module clients have these SEVIS-mapped fields added to their TDS Platform sites when the SEVIS Module is installed
- SEVIS Module (directed by DSOs & AROs) grabs SEVIS-mapped data from F/M/J visa holders records in the TDS platform and inserts them into their corresponding field in SEVIS.

SEVIS Module TDS Sandbox & Production sites have around 180 pre-built fields when clients

# Admin vs. User/Applicant - Who's Who?

## ADMIN

- DSOs/AROs/Admissions Counselors/Application Reviewers
  - Essentially, anyone within the functional office or on campus that needs to add/edit/review user files
- Admins can also have the ability to build/manage/edit TDS process or structural piece
- There are also different shades of Admin - not all admins have the same view/permissions/access to TDS
  - Facilitators
  - Reviewers
  - Recommenders
  - Maintenance

## USER/APPLICANT

- F/M/J visa holders, other non-immigrant visa holders, applicants for admission
  - Essentially, anyone who is interacting with TDS to review/initiate applications/requests/updates for /about themselves who enter in information related to themselves
- In most cases, Users/Applicants will only be able to see information contained in their electronic file, not the info of other users/applicants

# Academic Objective Records

- The crucial SEVIS record for F/M/J students and scholars
  - Contains information required to create a new student/scholar's SEVIS Record
  - Info in this record will be updated and maintained throughout the duration of their status
    - Program Start/End Dates (Start/End Dates)
    - SEVIS Status (Record Status)
    - Academic Objective Info (Questionnaires)
    - Education Info (Questionnaires)
    - Financial Info (Questionnaires)



# SEVIS Updates and Benefit Requests

- Can be initiated by F/MJ visa holder or by an Admin
- When a record/application for a specific SEVIS Update or Benefit is created, SEVIS-mapped fields get expressed which can be filled out by the F/MJ visa holder or the Admin
- When a DSO/ARO creates a SEVIS update record in the SEVIS Module for an F/MJ visa holder, the SEVIS Module grabs data from the specified record/application and pushes that data into SEVIS
